

Assistant Professor (tenure track) Canada Research Chair (CIHR, Tier II) in Micronutrients and Human Health

The Faculty of Land and Food Systems (LFS) at the University of British Columbia (Vancouver campus) (www.landfood.ubc.ca (<https://www.landfood.ubc.ca/>)) is currently accepting internal applications from outstanding researchers with a current full time faculty appointment in LFS at the rank of Assistant Professor (tenure track) for a **Canada Research Chair (CIHR, Tier II) in Micronutrients and Human Health**. This position will be part of the Human Nutrition (HUNU) group in the Food, Nutrition and Health Program.

Candidates must hold a Ph.D. in Human Nutrition. Applicants should have a very strong scholarly record, comprising high quality publications in leading journals, and demonstration of an early track record of success in graduate student recruitment and supervision, teaching, and obtaining funding from multiple granting agencies that ideally includes a diverse set of national and international collaborators. The successful applicant will have experience working in the field of nutritional anemia, with a focus on iron, zinc, and or folic acid, and including the role of micronutrient supplementation in children, women, and families in Canada and globally.

Nominees for Tier 2 Chair positions must be emerging scholars no more than 10 years from their highest degree at the time of nomination. Applicants with more than 10 years owing to legitimate career interruptions (maternity, parental, or extended sick leave, clinical training, etc.) may have their eligibility for a Tier 2 chair assessed through the CRC program's Tier 2 justification process which involves submission of a Tier 2 Justification Assessment form to the Tri-Agency Institutional Programs Secretariat. Consistent with the priority areas of strategic strength in LFS, the successful candidate will strengthen the position of LFS position as a leader in integrated research that promotes nutrition and well-being for healthier communities through the study of dietary patterns, whole foods, individual nutrients, and non-nutritive food components at the whole body, cellular and molecular level in various population groups and model systems. In particular, the successful applicant will evaluate the benefits and potential harms of nutrition supplementation policies and programs designed to treat

anemia, including iron and folic acid supplementation in women and children globally, and will work to improve diagnostic methods and investigate new biomarkers for anemia and iron deficiency for individual- and population-level assessment.

Faculty members in the HUNU Group conduct research that shapes fundamental nutrition knowledge, clinical practice, educational pedagogy, and public health approaches to Nutrition. HUNU engages with a diverse group of stakeholders including local, national, and international health care providers and governments on such topics as school food policies, community food programs, nutritional screening and interventions, international nutrition interventions and global nutrition policies.

Applicants should provide a 1) two-page cover letter; 2) detailed curriculum vitae; 3) names and contact information of three references, 4) five-year research plan (1-2 pages) to Dr. David Kitts, Associate Dean Research at david.kitts@ubc.ca (<mailto:david.kitts@ubc.ca>) by **January 4, 2021**.

In assessing applications, UBC recognizes the legitimate impact that leaves (e.g., maternity leave, leave due to illness) can have on a candidate's record of research achievement. The information you provide will only be used to determine whether you qualify for participation in this hiring process. Data will be collected by the Equity & Inclusion Office and only the names of those who identify as women, visible minorities (member of groups that are racially categorized) and/or Indigenous peoples will be shared with the search committee. BC welcomes and encourages applications from people with disabilities.

Equity and diversity are essential to academic excellence. An open and diverse community fosters the inclusion of voices that have been underrepresented or discouraged. We encourage applications from members of groups that have been marginalized on any grounds enumerated under the B.C.
